EXPLANATORY NOTE

WHEREAS, the Sangguniang Bayan of Tiwi, Albay passed, approved and enacted Municipal Ordinance No. 2020-8 dubbed as "An Ordinance Extending the Deadline for the Payment of Taxes, Fees and Charges Imposed and Collected by the Local Government Unit and Deferring the Imposition of Interest, Surcharges and Penalties Thereof as Means of Economic Relief to Individuals and Business in the Entire Municipality of Tiwi, Albay;

WHEREAS, the measure was prepared in response to Presidential Order #s 922 and 929 which laid broad strategies and guidelines governing the imposition of the Community Quarantine (CQ) over the entire Luzon and implementation of stringent social distancing measures throughout the country and the Republic Act # 11469 otherwise known as Bayanihan to Heal as One Act that places the country in a state of National Emergency due to the threat of COVID-19;

NOW THEREFORE, on motion duly seconded and approved unanimously by the members of the Sangguniang Bayan of Tiwi, Albay in session assembled, be it

RESOLVED, as this Sangguniang Bayan of Tiwi, Albay hereby resolved to enact to herein ordinance as follows:

Municipal Ordinance No. 1-2021

AN ORDINANCE AMENDING SECTION 2 AND 3 OF MUNICIPAL ORDINANCE NO. 2020-8 OTHERWISE KNOWN AS ECONOMIC RELIEF ORDINANCE TO INDIVIDUALS AND BUSINESS AFFECTED BY THE COVID-19 COMMUNITY QUARANTINE IN THE MUNICIPALITY OF TIWI, ALBAY

BE IT ENACTED by the Sangguniang Bayan of Tiwi, Albay, to wit:

Section 1. It shall be the policy of the Local Government Unit of Tiwi, Albay to provide the same economic relief assistance to individuals and businesses in the entire Municipality of Tiwi, Albay;

Section 2. This ordinance hereby governs the extension of the payment of all business taxes, fees and charges imposed pursuant Municipal Ordinance No. 2019-3 to March 31, 2021;

Section 3. This ordinance hereby governs the deferment of the payment of all interest, surcharges and penalties of all unpaid taxes, fees and charges imposed pursuant Municipal Ordinance No. 2019-3 for the period January 20, 2021 until March 31, 2021;

Section 4. The Section 2 and 3 of Municipal Ordinance No. 2020-8 is hereby repealed by this ordinance.

Section 5. This Ordinance shall take effect immediately upon approval.


