EXPLANATORY NOTE

WHEREAS, on March 16, 2020, the Sangguniang Bayan of Tiwi enacted Municipal Ordinance No. 2020-4 that establishes the curfew hours from **8:00 P.M to 4:00 A.M** for minors and adult who lives and sojourns in the municipality of Tiwi, Albay;

WHEREAS, on July 20, 2020, the Sangguniang Bayan of Tiwi amended the said ordinance by revising curfew hours from **9:00 PM to 4:30 AM** given that the province of Albay was put under Modified General Enhanced Community Quarantine (MGCQ) under the MGCQ category business establishments and other economic enterprise can now operate until Category 4 but limited to 50 percent capacity only;

WHEREAS, on December 5, 2020 the Sangguniang Bayan amended the Curfew Ordinance by revising curfew hours from 10:00 PM to 3:30 AM in Lieu of the Christmas Season to give ample time for

traditional Christmas Celebrations that are essential in our culture as a community but following basic health protocols and policies given by the IATF

WHEREAS, upon the recommendation of the Local Inter Agency Task Force there is a need to amend the said ordinance given the rapid increase in the number of covid positive in the municipality of Tiwi.

WHEREAS, to avoid more amendments in the curfew ordinance for the duration of the declared municipal wide health emergency the said curfew ordinance is suspended during holidays and in conduct of Religious Activities as provided in Section 6 of the revised ordinance

WHEREAS, the Inter Agency Task Force have given LGU's the power to enact necessary legislation and executive orders depending on the need and the quarantine classifications of each city or municipality;

NOW THEREFORE, the foregoing premises considered, in session assembled, hereby ordain as follows:

Municipal Ordinance No. 2-2021

AN ORDINANCE AMENDING SECTION 5 OF THE AMENDED CURFEW ORDINANCE NO: 2020-23 ENTITLED: "AN ORDINANCE IMPLEMENTING EXPANDED COVERAGE OF CURFEW HOURS IN TIME OF EPIDEMIC AND OTHER NATIONAL OR MUNICIPAL WIDE EMERGENCY"

BE IT ENACTED by the Sangguniang Bayan of Tiwi, Albay, to wit:

Section 5. Expanded Coverage Curfew Hours. Once a nation-wide health emergency or municipal-wide health emergency is declared by the proper authorities, the following curfew hours of 9:00 p.m. to 4:00 a.m. of the following day (except for declared holidays and conduct of religious activities such as Holy Week and Town Fiesta) for minors and adult, respectively who lives and sojourns in the municipality at the time of its effectivity shall automatically be in force and effect within the territorial jurisdiction of Tiwi, Albay.


