Municipal Ordinance No. 7-2021

WHEREAS, the Local Government Code of the Philippines RA (7160) empowers the Sangguniang Bayan a legislative body enact ordinances, approve resolutions an effective and efficient local government and this connection shall determine the position and salaries, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and to provide expenditures necessary for the proper conduct of programs, projects and activities of the municipal government;

WHEREAS, Pursuant to Budget Circular 2020-4 Upgrading of the Entry Level of Nurse Positions Section 2 (Purpose) This circular is issued to prescribe the rules and regulations on the upgrading of the entry-level of Nurse I Positions to SG-15, as well as to highlight the administrative procedures in view of the consequential modification in the position attributes of the Nurse items. Section 8 (Modification in the Position Attributes of the Nurse Position) The position attributes of the following classes of Nurse positions are hereby modified:

WHEREAS, in response to the request of the Municipal Mayor and after thorough inquiry and analysis, the Sangguniang Bayan deemed it necessary to create the position of Nurse II under the Municipal Health Office.

NOW THEREFORE BE IT ORDAINED BY THE SANGGUNIANG BAYAN in session duly assembled that:

SECTION 1. Creation of Position: There is hereby a created position "Nurse II" Salary Grade 17 under the Municipal Health Office.

SECTION 2. Qualification, Duties and Responsibilities

Qualification:

Education: Bachelor of Science in Nursing

Experience: 1 year of relevant experience

Training: 4 hours of relevant training

Eligibility: RA 1080

Duties and Responsibilities:


1. Provides leadership in planning for total health care to all individuals, families and community in assigned areas.
2. Assist in determination of the Philosophy and objectives of the community health program.
3. Guides and supervises the functions of other nurses and other health workers assigned under her supervision.
4. Carrying out preventive, promotive, curative and rehabilitative care.
5. Assist in the development of the standard of health care with the accepted philosophy, objectives and health policies.
6. Assist in the preparation of budget allotted to the Health Department.
7. Organize educational programs for the community.
8. Supervise records and reports prepared by health workers working under her jurisdiction.
9. Supervise, train and guide the health workers in the delivery of health care service in the community.
10. Supervise and assists in the implementation OF National Health Programs.
11. Improves quality results by studying, evaluating and recommending changes in the processes and programs.
12. Serves patients by visiting homes, determining patient and family needs, developing health care plans, providing nursing services and treatment, referring patients with social and emotional problems to other line agencies.

Funding: Expenses for Personal Services shall be charged against the supplemental funds for the next supplemental budget of the LGU-Tiwi provided it does not exceed the PS Limitation as prescribed by law.




