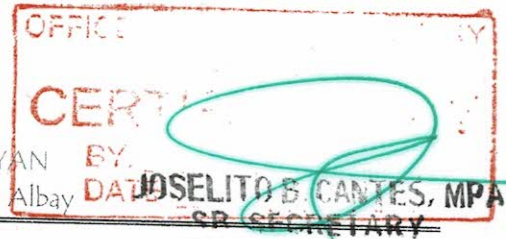

EXPLANATORY NOTE

WHEREAS, Section 76 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 447 (a) (VII) of the same Code provides that the Sangguniang Bayan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the municipal government;

WHEREAS, like any other dynamic organizations, the municipal government of Tiwi have to continuously adjust to rapid change-form a mere provider of traditional basic service local government units will now assume more complex roles in socio-economic development and will continue to help shape the developmental directions of our country;

Municipal Ordinance No. 6-2021

AN ORDINANCE TRANSFERRING THE MEAT INSPECTOR I POSITION FROM THE LOCAL ECONOMIC ENTERPRISE (OPERATION OF MARKET) TO THE LOCAL ECONOMIC ENTERPRISE (OPERATION OF SLAUGHTERHOUSE)

SECTION 1. The position below is hereby transferred:

- (a) From: Local Economic Enterprise (Operation of Market)
To: Local Economic Enterprise (Operation of Slaughterhouse)



SECTION 2. The employment of offices/employees affected by the aforementioned transfer of plantilla position in the municipal government of Tiwi shall be deemed transferred to said section of the office without reduction of salaries and other benefits and without loss of rank including the plantilla position he/she occupies.

SECTION 3. The corresponding salary and other benefits of the position mentioned in Section 1 (a) shall be appropriated in their new section assignment which is incorporated in the General Fund Annual Budget for Calendar Year 2021.

SECTION 4. This Ordinance shall take effect upon its approval.






