Municipal Ordinance No. 9-2021

SECTION 1. Section 2 and 3 of Municipal Ordinance No. 10, Series of 2020 is hereby amended, and shall now read as follows:

"Section 2. There shall be a collected amount for every Rapid Test undertaken by the Local Government Unit of Tiwi, Albay as follows:

- a. Locally Stranded Individuals (LSIs)- Six Hundred Pesos (Php 600.00) per test;
- b. Authorized Persons Outside Residence (APOR)- Six Hundred Pesos (Php 600.00) per test;
- c. Returning Overseas Filipinos (ROF)-Six Hundred Pesos (Php 600.00) per test;

Section 3. The LSIs, APOR, and ROF who have undertaken any of the following test shall not be required to undergo Rapid Test:

- a. RT-PCR Test which was administered five (5) days before the arrival;
- b. Saliva/rapid antigen test which was conducted three (3) days before the arrival;"

SECTION 2, Effectivity Clause. This Ordinance shall take effect upon its approval.


